The bids should be submitted at 12:00 pm 2078/01/23 and Bid will be opened in the presence of Bidders' representatives who choose to attend at 2:00 pm 2078/01/23 at the office of Nisikhola Rural Municipality Devisthan Baglung. Bids must be valid for a period of 90 days after bid opening and must be accompanied by a bid security, amounting to a minimum Nrs 85496 which shall be valid for 30 days beyond the validity period of the bid.
- 6. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
